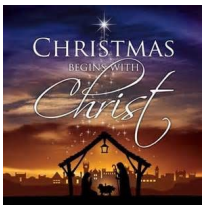
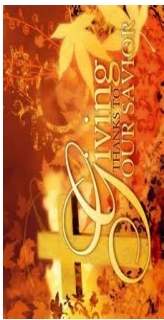

**We** are excited to be in the midst of this holiday season with gratitude in our hearts for yet another year. It seems 2015 just began when all of the sudden, it is soon to be gone. We are grateful for the many challenges and the many blessings this year has brought, and is still bringing. We recently had the opportunity to host our Pastoral-Care couple from CTEN (Commission To Every Nation), David and Janice Ewing. They come periodically from the CTEN home office in Kerrville, Tx. to visit CTEN missionaries in Guatemala. Having been missionaries in Guatemala, they understand many of our needs and simply love on us! We are grateful for the support we feel from our mission-sending organization, from our supporters and from our friends and family. We recently read our 1995 journal written when this whole journey first started, some twenty years ago. It was a great reminder of how God works in our lives. He left no room for us to doubt He wanted us serving Him in Guatemala.



**Thanks** to our supporters (individuals and churches alike), this year we were able to make room-additions for needy families who live in humble corrugated-tin homes, sponsor a number of impoverished children in their education, supply medicine for a young man who has seizures, run four Bible Studies each week, celebrate various group events throughout the year, help a couple with two young children get married and host various houseguests. Recently, we were able to arrange surgery by a private surgeon on 11 year old, Mario David. David has been part of the Children’s Bible Study since he was wee little. His single-parent mother travels from afar to be here every week with her three children who were abandoned by their father. David broke his arm over a year ago. As a result of two botched surgeries by the national hospital, not only was his arm *not* healing, but it had developed a bad infection. The surgeon (a specialist) offered his services at no cost. He removed the poorly installed titanium plate and is treating the infection. Thanks to generous donors, we were able to cover the cost of the hospital and the anesthesiologist. *We are in need of additional support for David.* He still has a long road ahead of him with medical appointments, medicines and x-rays. We are hopeful to avoid another surgery. We ask you to pray for his bones to fuse. Like every boy his age, he is energetic and wants to play soccer again. Despite this being his writing hand, David passed his school tests orally when the school year ended in October.
